"My tenure started with an outstanding conference in late 2009 on the political and social dimensions of the global financial crisis." <http://www.unrisd.org/publications/cn25e> "The global context was marked by fiscal retrenchment, cuts in social spending, high unemployment, tightening aid budgets and on-going debates about viable policy alternatives for achieving balanced growth without compromising the poverty reduction and social gains of recent years. For UNRISD, these trends translate into new and urgent demands for research on social development, but also a restrictive resource environment for launching such work. The past year was marked above all by a high level of uncertainty: we enter 2011 with hope for greater security for all."

"For UNRISD, the highlight of the year was the publication of our long-awaited report *Combating Poverty and Inequality*. http://www.unrisd.org/publications/povertyreport360page_USD45. The key messages, alongside detailed empirical support and policy options, speak directly to development debates and challenges that have been intensified by crisis: that addressing the multiple facets of inequality is inextricably bound up with reducing poverty and achieving inclusive growth; that the creation of productive employment must be a core goal of economic development; that social policies play an essential role in growth, equity, social reproduction and social cohesion—all of which are necessary for sustained poverty reduction; and that poverty reduction requires a serious analysis of the political arrangements that enable the poor to have voice in policy processes."

Poverty and inequality are both products and producers of the prevailing relationships of power in a society. By many definitions, social movements are understood as questioning the nature and exercise of power in society. As such they also play roles in challenging relationships of poverty and inequality. This paper explores some of these roles.

The paper first discusses characteristics of social movements—their motivations, emergence and strategies. Languages of justice and rights are far more prominent in social movements than are languages of poverty reduction. Movements rarely take on the mantle of "being poor" as an identity-based grievance, and few movement leaders think of themselves or their bases in this way. Indeed, many movements argue that a policy focus on poverty is depoliticising and diverts attention from structures of inequality and exclusion.

The ISS produces much information of interest to social development practitioners in the January edition of the ISS Newsletter <http://www.iss.nl/About-ISS/ISS-newsletter/General-Newsletter-no.15-January-2011#events> there is coverage of *Gender trends in developing countries during financial crises* This paper looks at several financial crises: the Asian financial crisis, the Brazilian, Argentine and Turkish financial crises, around the turn of the last century. Data are analysed for a 10-year period around these crises. The data include gender indicators (mostly female-male gaps) in education, health and the labour market and show lack of progress or even declines in gender equality in these periods of crises in the eight countries analysed. Moreover, a control group of countries is used as

counterfactual, indicating better performance on gender equality and hence, a diverging trend between the two country groups.

Institute attendees transitioning to top leadership positions will be provided with state of the art knowledge about NGO leadership, competency and talent development approaches, as well as strategic and analytical skills. The program will enable participants to examine their personal leadership style, expand specific competencies and roles and network with peers.

Participants will examine five issues they are likely to encounter when making this leadership "leap":

- Leading in a complex context: the broader landscape of actors and issues
- Organisational governance: board leadership, organisational change and design
- Collaboration: communication, networks, partnerships, collaborative governance and leadership
- Power relationships: politics, symbolic leadership and leadership in times of change and crisis
- Strategic resource mobility: allocation and management
