We are calling for nominations for various positions that become vacant in 2020.

#### **Candidates**

Every nomination form must be sent with a one page statement by the candidate on what he or she would seek to achieve, what his or her contribution to ICSW has been and a statement that he or she has time and dedication to take on the position.

#### **Nominations**

### **Management Committee**

Nominations for the following positions may **ONLY** be made by National Member Organisations (Category A)

President - Four year term, open for nomination in 2020.

Vice President - elected for 4 years in 2018

Treasurer: elected for 4 years in 2018

Member of the Management Committee - coming from members listed below who pay five

shares and below: elected for 4 years in 2018

Member of the Management Committee coming from members who pay six or more shares:

Four year term - Open for nomination in 2020

# Supervisory and Advisory Board (Regional Presidents)

Nominations for Regional Presidents can be made by **ANY** member organisation in a region. Regional presidents from the following regions have served their term and cannot be re-elected; North America and the Carribean, Latin America and North East Asia.

### **Advice on Elections**

- 1. Nominations close on 21st April 2020.
- 2. Elections will be conducted electronically with the whole process concluding on 31<sup>st</sup> May 2020 30 days before the meeting of the General Assembly on 30<sup>th</sup> June 2020.
- 3. Use a separate form for each person.
- 4. Indicate for which position or positions the person is nominated.
- 5. A person may be nominated for more than one position.
- 6. A person can only be elected to one position.
- 7. Elections will be held in the order on the nomination sheet.
- 8. The form must be signed by both the nominator and the candidate for election.
- 9. If a candidate comes from a member organisation a representative of that organisation must endorse the nomination. If the candidate does not come from a member organisation the nomination must be proposed by a member.
